<u>Not required to attend if on contract:</u> Internship I Orientation; A separate virtual orientation can be held for paraprofessionals at the end of the school workday.	Regarding the eight days of substituting that is required, it is recommended that the paraprofessional be afforded the opportunity to substitute in a classroom outside of his/her daily responsibilities as this is a UHCL requirement for all TCED 4978 clinical teachers. The campus administration has the authority to remove a paraprofessional from his/her daily schedule to substitute in a classroom. The paraprofessional will record the substitute experience on the Internship II/Clinical Teaching Classroom Coverage Information document.
