## **Affiliation Agreement**

agree to establish an affiliation for the purpose of providing a practicum or internship course for a student at the University. University and Agency/Facility shall be known collectively as "Parties" and singularly as "Party".

The University and Agency/Facility mutually agree that:

- 1. The purpose of field placements is to provide opportunities for teaching and learning activities that will enable the student to meet stated objectives.
- 2. There shall be open channels of communication between the University and the Agency/Facility relative to the field practicum or internship through designated representatives.
- 3. The beginning and ending dates for field practicum or internship courses will be determined by the University.
- 4. The term of this Agreement shall cover the following period:

- 5. Any of the parties may withdraw from this affiliation by giving seven days notice in writing to the other party.
- 6. Under this Agreement, University, students and University personnel, including faculty, shall not be considered employees, agents, borrowed servants, partners, or joint venturers of Agency/Facility.
- 7. Agency/Facility is not responsible for wages, social security taxes, medical insurance, or workers' compensation insurance for students. In the event a student should participate in a paid internship program, or independent of the Agreement be employed by Agency/Facility, this section and section 6 shall not apply.

# The University agrees to:

- 1. Assign a faculty person to serve as an internship or practicum supervisor. This representative will make appropriate visits to the Agency/Facility during the semester as is appropriate.
- 2. Select students who shall be placed at the Agency/Facility, subject to the approval of the Agency/Facility.
- 3. Restrict the activities of its internship or practicum supervisor from performing any service of the Agency/Facility except in the course of performance of field instructions, unless otherwise contracted.
- 4. Respect the mission of the Agency/Facility and both expect and require students to accept Agency/Facility clientele, staff, and administrators, regardless of race, ethnic origin, sex, age, religion, or political belief.
- 5. Withdraw upon written request any student whose performance is unsatisfactory or whose conduct is unacceptable to the Agency/Facility.

# The Agency/Facility agrees to:

- 1. Accept qualified students for the field practicum or internship in the Agency/Facility with the provision that the students may participate in overall Agency/Facility programs and activities as appropriate.
- 2. Accept students without regard to race, ethnic origin, sex, age, religion, or political belief.
- 3. Provide appropriate instruction by a qualified Agency/Facility representative, hereafter known as the field supervisor, approved by the University.
- 4. Allow the field supervisor time to prepare for conferences with the students; to maintain scheduled conferences with the students; and to consult with the University's representative.
- 5. Provide the students with essential conditions and materials for their work, including space, privacy, and technological support, and reimbursements for work related expenses.
- 6. Inform the University of changes in Agency/Facility policy, procedures, and staffing that affect field practicum or internship courses.
- 7. Withdrawal of the student by the University when the placement fails to be in the best interest of the student, Agency/Facility, or University.

## **General Provisions**:

- 1. Parties agree that this Agreement will be construed by the laws of the State of Texas, exclusive of its conflict of laws provision.
- 2. The terms and conditions of this Agreement may be modified upon mutual written consent of Parties at any time.
