Academic Council Meeting Minutes

Thursday, February 17, 2022 2:00 p.m. – 3:30 p.m. (ZOOM)

Approval of December 16, 2021 Minutes- minutes were unanimously approved.

A. Items

1. Faculty Workload Policy (Elizabeth Beavers)

Provost started the discussion, stating the committee will follow Robert Rules of Order for this item; vote on next AC meeting. Mark Denny requested to complete a Financial Analysis to include budget and tracking implications. Item will be added in TEAMS week prior to meeting to allow for review.

S. Costello provided outline of policy progress. The current policy dates to 1997 requiring an update. Normally, Faculty Life develops a policy but former Provost Berberich requested this policy be developed in collaboration with the Provost's Office and different constituencies. The group met several times though August 2021. She pointed out section 5.8 addresses faculty who are asked to create new online courses. Other changes were to Preamble.

E. Beavers requested Deans share discussion points to consider.

Dean Sanford:

- Requirement of TA and Overload re: support of large classes
- No flexibility; states faculty will have a TA
- Class caps
- Policy shows program lead rather than Dean

Dean Pedro:

- Financial implications need to be verified.

Dean Waller:

- He referenced an example of COB numbers and how the DRAFT may impact COB
- Suggestion: may be useful to know why there is a continuous sliding scale rather than brackets.
- History of various numbers in the many drafts, may be useful to review progression from 50 to 40 rather than 60.



S. Costello:

- Sliding scale allows more for attrition of students.
- Tried to incorporate as much flexibility can be taken as course release or paid.
- Class enrollment in class for formula purposes defined in the policy as census date. *Provost recommends census data be noted in all applications.*
- P. Withey requested that M. Denney's analysis separate the cost of administrative reporting from cost of policy.

Provost will request Mr. Denney separate both analyses.

E. Beaver asked how item will now proceed.

Provost recommended a subgroup of Faculty Senate and the Deans to come together to review for accuracy, clarify intent utilizing the time to discuss non and substantive changes and any inconsistencies. There was no dissent stated to the recommendation.

2. Centers for Institutes Policy – A. Dubrovskiy introduced the item (see attachment). Purpose is to establish procedure for centers and institutes both current and creation of new; inspired by UH policy. He stated centers and institutes will be designated by Office of the President, whether college or university-level and require Advisory Councils, and annual and cumulative reports. College level reports reviewed by Deans; university by Provost.

The item was unanimously approved and will move to University Council for the March 2022 agenda.

3. Writing Requirement - Becky Huss-Keeler introduced the item (see attachment). Proposal that S. Gladden brought forth (not through HSH), after he noticed in Core Curriculum Committee that the added writing requirement Introduction to Professional writing did not get into the catalog. The requirement has already been approved as a lower level requirement for students to be able to take.

The item was unanimously approved and will move to University Council for the March 2022 agenda.
