Information Items:

- Fee increases proposal
 - 10% increases will be presented to students next week for 2025 and 2026.
- EV charging stations 4-hour limit
 - Updates to signs will be made to confirm changed length of charging time from 3 to 4 hours this semester. Concern regarding only 3 charging stations. Due to budgetary constraints we cannot at this time increase the number of charging stations. Can go to gas stations as well. The future may be that we won't need to increase ours. Cost of running electricity for more charging stations would also be high. We may be able to add 1 or 2 on down the line but can't run electricity to far side of parking lot due to electricity costs.
- Parking Lot Chains and Bollards update
 - Doug Wells will be investigating other options.
- Support Staff parking spot update
 - The staff awards parking space allocation near other buildings is under consideration and will not be ready until fall 2024.

- o Accessibility Parking in front of SSCB in Lot B
 - We are required to have 9 spaces federally. May have to add more to SSCB lot. We try to allocate by workspace percentages.
- Student Center Plans for Lot B
 - Increase authorized for new student center in lot B. This will consume 150 – 200 parking spaces. Will ask for CCAP funding for Stem II which will consume northern part of lot B. A decision will have to be made how to increase parking.
