4. Nominee must be able to accept the award in person at the annual UHCL Alumni Celebration dinner.
5. Nominee must not be a current member of the Alumni Association Executive Council.

### SECTION 3 – AUTOMATIC INELIGIBILITY

An individual shall be ruled ineligible to receive the Distinguished Alumni Award if any of the following conditions prevail at the time the selection committee meets to consider nominations:

1. Nominee is a candidate for any public office.
2. Nominee is a member of the selection committee.
3. Nominee is a previous recipient of the award.
4. Nominee has been convicted of a felony.
