- Submit name, form provided
- Complete forms
- Submit completed forms to classroom teacher or principal
- Wait for administrative clearance
- Begin work

In order to ensure the safety of our students, local board policy dictates that AISD shall perform a criminal history record check on all employees as well as substitutes and volunteers. [See Texas Education Code 22.083(a)(b), Board policy DC (Legal), DC (Local), GKG (Legal), and GKG (Local)].

In addition, Education Code 22.053 states, "A volunteer who is serving as a direct service volunteer in the district is immune from civil liability, to the same extent as a professional employee of school district under Section 22.051.

The information obtained by the district concerning criminal background history remains confidential just like medical records.
