Treasurer's Report, Chair April Harris

Updated budget balances were provided.

• Shared Governance Reports

University Council, Veronica Ortiz

Optional, Summer Four Day Workweeks run from June 8-July 28. Alternative Work arrangements will be paused if moving to 4-10 work week. All offices must stay open Monday through Friday, from 8am to 5pm. On Holiday weeks, employee schedules return to normal schedule. Lunch is required, and cannot be taken at the end of the day. A Budget initiatives update was given regarding salary and merit being top priority. Legislative updates were given regarding the Diversity, Equity, Inclusion (DEI) and Tenure Bills, that they are currently pending in the House of Higher Education Committee. It was announced that University of Houston's Chief of Staff/Chief Strategy Officer will begin their role between July 10th and August 1st. New Student Building update was given; student referendum was passed 62% to move forward. The next step is getting Board of Regents and Legislative approval.

Facilities & Support Services Committee, Bianca Schonberg and Lee Ann Wheelbarger

A Student Services and Classroom Building (SSCB) construction update was given. There will be a facelift given to the Student Assistance Center (SAC) to support more students at a quicker pace which is scheduled to be completed by early June. Two accessible parking spaces were installed by the STEM building. The sign that read "parking prohibited" was removed at the nature trail. Mark Denney is looking into changing the 3-hour limit on electric parking. Facilities Management and Construction is looking into shuffling spaces for large groups. Parking and Transportation update was given, there is a parking price increase of \$5 which according to Mark Denney is necessary for new parking. There is a possibility that University of Houston Clear Lake will get a parking garage. USA is working to get a traveling parking spot space for the monthly Hawk Spirit award winner.

Planning and Budget Committee, Kurt Lund and Megan Bearden

The last meeting held on March 29, 2023 was spent reviewing and approving the scores that were submitted by all the representatives. 19 initiatives will be presented in four quartiles to University Council.

New business introduced was an update to the By-laws, and two new policies

Voting updates were provided. By Laws and friendly amendments were voted on, more ex-officio members from the Chief Diversity and Title IX offices, and the by-laws were approved by majority vote.

Meeting with Dr. Walker

Veronica updated everyone on the monthly meeting with Dr. Walker.

Dr. Walker provided legislative and University System Executive Council agenda updates.

The Climate Survey is on pause until this Fall. Dr. Walker had concerns regarding DEI issues, # of questions, home grown survey (not data based). He would prefer something similar to the COACH survey. If we move into the more national survey direction, Veronica would like to include something that applies to our campus personally. Regarding Staff Comp Analysis, He is working on the contract with the firm he has chosen, and it should happen in the next fiscal year.

Veronica provided updates from the University System Executive Council quarterly meeting and regarding the Duck races and future events.
