#### **Research Activities**

2013-present: Anxiety and Depression Research

Time perspectives and anxiety: Various research groups have examined how participants' time perspectives about negative events and emotions are associated with risk for anxiety and depression. In their current project, Dr. Lauderdale and his lab are investigating which of these perspectives are better a predicting cognitive risks for and symptoms of anxiety and depression.

2013-present: Indecisiveness Research

Indecisiveness has long been recognized as a symptom of several mental disorders, including Major Depressive Disorder, Obsessive-Compulsive Disorder, and Hoarding. Dr. Lauderdale and his lab were the first to publish research demonstrating that Aversive Indecisiveness, a dispositional form of indecisiveness associated with negative expectations about decision-making, was uniquely predictive of risks for and symptoms of anxiety and depression. In on-going projects, Dr. Lauderdale's lab has revaluated a measure of indecisiveness to evaluate the underlying factor structure. Dr. Lauderdale's lab also has data demonstrating that indecisiveness is distinct from other related constructs, such as procrastination. Current projects are assessing other cognitive factors associated with indecisiveness, such as perfectionism, fear of guilt, and fear of failure. Finally, Dr. Lauderdale and his lab have added new items to the revised Indecisiveness Scale to address limitations of the measure. Preliminary findings with over 400 participants indicates this measure improves on the prediction of cognitive risks for and symptoms of anxiety and depression.

### 2015-present: Veteran Research

Public Stigma: Few researchers have examined public stigma for veterans. In a series of projects, Dr. Lauderdale and his lab are examining various factors associated with public stigma for men and women veterans with combat-related PTSD (CR-PTSD). Recent projects include evaluating gender differences in stigma for men and women with CR-PTSD. Data is also being collected to determine how perceived control over exposure to CR-PTSD may influence stigma. Other variables being examined include gender role beliefs, empathy, and participants' experience with PTSD.

New projects underway include evaluation of how traumatic brain injury (TBI) may influence stigma. TBI is considered a major factor affecting veterans of OIF/OEF/OND, with over 25% of veterans experiencing TBI. No research has yet examined whether a veteran with TBI+CR-PTSD experiences more stigma than a veteran with CR-PTSD. Results could have implications for prejudice and discrimination.

Military Sexual Trauma: Military sexual trauma (MST) of women and men has persisted at a high rate for many decades. Research has yet to evaluate the public's perspective of veterans with MST. This project has received IRB approval and data collection is pending.

Transition from the military, NEW MOS: Few measures have been developed to quantify challenges experienced by veterans following military separation. Based on a review of the scant literature available, Dr. Lauderdale and his lab have constructed a preliminary scale that could be used to quantify veterans' experience of military separation. Results could have implications for helping veterans and service providers manage military separation.

Program Evaluation, North Texas Regional Veterans Court: Dr. Lauderdale and his lab have been selected to provide program evaluation services for the only regional (spanning five counties in north east Texas) veterans' court in the United States. Our data will be used to train other criminal justice professionals (e.g., judges, probation officers, court coordinators) to establish regional veterans' courts in other Texas counties and states.

### 2018-present: Older Adults and Technophobia

In collaboration with other researchers, Dr. Lauderdale and his lab are examining the psychometric properties of two innovative measures: a technophobia scale and smartphone challenge task for older adults. Preliminary evidence suggest the technophobia scale and smartphone challenge task have excellent internal consistency and concurrent validity.
