Position: Director EHS

Location: New England

My client is a small, fast growing, international chemical company. They are looking for someone that is both strategic and tactical, to own the company's environmental, health, safety and product stewardship needs. This person will be supported by four direct reports, one of which is in Asia. The company has 3 manufacturing facilities, and a number of sales offices in Asia and Europe.

Qualifications: BS in Safety, Engineering, Environmental or related; 10+ years chemical industry and corporate experience; in depth knowledge of product stewardship.

Position: EHS Manager

Location: Northeastern IL

My client is a global food manufacturer with 13 locations. This is a newly created position and will be responsible for developing and implementing eh&s policies for their U.S. locations (2). The plants' security personnel will report to this position and 6 managers will indirectly report into this position. This is an opportunity to define, build and implement your own programs and directly influence the health, safety and environmental well being of this company's U.S. employees.

Qualifications: 5+ years safety, health and environmental experience; BS degree in Engineering, IH, Safety or related; ergonomics experience; eh&s experience in food manufacturing environment is a plus. No relocation offered at this time.

Position: EHS Manager

Location: King of Prussia, PA area

This position will be the sole environmental health and safety professional for this plant. The large majority of the work will be in the safety area for this film manufacturer. This is a small plant with about 100 employees.

Qualifications: BS in Safety or related. There is very limited environmental work associated with this position so knowledge of environmental is not required; 5+ years safety experience in a manufacturing environment; currently there is no relocation assistance.

Position: Safety Engineer

Location: Lancaster, PA area

Job Description: This person will provide the full scope of safety and health support to maintenance and contractors on site, to include equipment safety such as lockout/tagout, confined space entry and supporting construction projects, etc.; work to design protective equipment and devices for machines, redesign of machines and plant equipment to eliminate hazards; drive safety culture change with human performance tools and develop and audit incident prevention programs; leads cross-functional teams in support of design and implementation of EHS projects

Qualifications: BS degree in Safety or related; minimum 5 years of hands-on, plant floor health and safety program management in a manufacturing facility; in depth knowledge and skill in support of equipment safety, fall protection, incident investigations and contractor safety orientation.

Position: Sr Safety & IH Manager

Location: Elmira, NY area

Job Description: Responsibilities include: develop and implement strategies to avoid hazards and provides solutions to safety problems and challenges within the facility; examines work environment for various physical, chemical biological and environmental stresses and partners with plant leadership to implement appropriate changes; interprets OSHA standards and is liaison with OSHA; manages safety department personnel; tracks safety performance and statistics to identify opportunities for improvement; ensures root causes are identified and corrective actions are implemented in a timely manner.

Qualifications: BS in Safety, IH or related; minimum 10 years safety and health work in a manufacturing environment; some preferences include: Master's degree, certification (CSP or CIH) and union experience.

Position: EHS Manager

Location: Seattle, WA area

Job Description: The EHS Manager has the primary responsibility for coaching, leading and influencing the operations management on EHS principles, practices and safety culture. In addition, this role will manage a small team of EHS staff, including their development and performance management.

Qualification: BS in EHS, Industrial Engineering or related, 5+ years experience in plant safety, supervisory experience and hands on health, safety and environmental training.

Position: Sr EHS Professional

Location: Greater NYC area

Job Description: Some of this position's responsibilities include: provide leadership and support to ensure ehs compliance, minimize liabilities and improve overall ehs culture; drive compliance with federal, state and county regulations; support the interface with regulatory agencies and third parties, as needed, on compliance and enforcement issues. Identify, track, report and drive improvement on ehs key performance indicators; guide and support implementation of the Responsible Care Management System; lead and/or participate on ehs and/or cross-functional work teams on development and improvement of company-wide processes and systems.

Qualifications: BS in Environmental Engineering, Environmental Science, Safety Science or related and 7 or more years of professional experience; at least 5 years of well-rounded ehs experience in a chemical manufacturing or related environment; in-depth knowledge of EPA and OSHA regulations.
